4. We may provide you with a TDA in hard copy or electronic format. If the TDA is furnished electronically, it will be provided in a Portable Document Format (PDF) file. You must use the Adobe Acrobat programme in order to open and view this type of electronic file.
5. Upon receipt of the TDA, please complete and sign the “Our Copy” duplicate. Once completed and signed, return the completed “Our Copy” to the address indicated above.
6. It is recommended that you review documentation with all relevant parties and business advisors.
7. All correspondence and documentation sent by us is strictly private & confidential and is not to be redistributed, replicated or distributed to any third parties unless for legal or financial advisors. Such a breach will terminate any and all agreements with immediate effect. This remains in force for all written or oral information disclosed.
